

TERMS AND CONDITIONS OF TICKET PURCHASE AND ATTENDANCE AT THE SYDNEY ROYAL EASTER SHOW

Please read these Terms and Conditions ("Terms") carefully as these Terms constitute an agreement between you and the Royal Agricultural Society of New South Wales ("RAS"). These Terms are to be read together with all other statements or directives either shown on any tickets issued to you or otherwise displayed at the Sydney Royal Easter Show. Each time you access, browse, interact with and/or purchase tickets to the Sydney Royal Easter Show from this website and/or attend the Sydney Royal Easter Show (as applicable), you agree to accept these Terms without limitation. If you do not wish to be bound by these Terms, you must immediately cease accessing, browsing, interacting with or purchasing tickets via this website.

You will be required to click to indicate acceptance of these Terms before you may purchase any tickets to the Sydney Royal Easter Show. The provisions of these Terms regarding entry into the Sydney Royal Easter Show may also be displayed at the Sydney Royal Easter Show.

RAS may amend these Terms from time to time by posting the amended terms on this website. All amended terms shall automatically be effective.

To purchase tickets to the Sydney Royal Easter Show via this website you must be sixteen (16) years of age or older. If you wish to purchase Sydney Royal Easter Show tickets but are aged under 18 years, you must obtain the consent of your parent or legal guardian to register a user account and provide personal information about yourself. If you are aged under 18 years, these Terms will bind you and any parent or legal guardian who gives their consent for you to purchase tickets to the Sydney Royal Easter Show via this website including all financial charges and legal liability that you may incur.

RAS is not responsible for the content of any site linked to or from this website. Your linking to any other site from this website is entirely at your own risk. While RAS may provide links on this website to other sites, the inclusion of such links is for your convenience and information only and should not be interpreted as an endorsement of the owner/sponsor of the site or the content of the site. To the full extent permitted by law, RAS disclaims all warranties, express and implied, as to the accuracy, validity, legality or otherwise of any materials or information contained on such sites.

SALE AND PURCHASE OF SYDNEY ROYAL EASTER SHOW TICKETS

Tickets for the Sydney Royal Easter Show are available for purchase at the prices set out on this website. Tickets must be purchased and paid for in the manner advised by RAS on this website. RAS does not accept Diners Cards. GST will apply to all tickets purchased via this website. The stated price of tickets will be inclusive of GST.

By purchasing and paying for a ticket via this website, you warrant you are the authorised holder of the credit card used for payment and/or have express consent of the authorised credit card holder to make the relevant purchase(s) and payment(s). RAS is not liable for any fraudulent purchases/payments or purchases/payments made by fraudulent means.

You may only purchase tickets to the Sydney Royal Easter Show via this website as a non-commercial consumer for your non-commercial, personal use. You must not purchase and/or use the tickets to the Sydney Royal Easter Show in a commercial capacity in any way (including but not limited to offering the tickets as prizes or gifts in a trade or consumer promotion/competition, raffle or as part of a corporate gift) without obtaining prior written consent from RAS. Tickets for the Sydney Royal Easter Show (whether purchased through this website or through other means) must not be resold or offered for resale at a premium (including but not limited to via on-line auction sites). If RAS believes a ticket is sold or used in breach of this condition, the ticket may be cancelled without a refund and the bearer of the ticket may be refused admission.

Scalping warning: The resale of tickets in certain circumstances may attract financial penalties.

If your ticket is not a 'Print at Home' ticket, then you must allow adequate time for collection or delivery of tickets purchased through this website. Methods of collection and/or delivery will be available when choosing your collection/delivery details.

Entry may be refused if tickets are damaged or defaced in any way or are not purchased from authorised points of sale. Except as required by law, RAS shall not refund or exchange any ticket(s) purchased via this website. RAS is not responsible in any way for tickets that are lost or stolen.

If you purchase a concession ticket, suitable and valid identification must be provided when collecting your ticket(s). RAS also reserves the right to request that you provide valid identification to verify your personal details (including but not limited to your name, address, date of birth) at any time during your attendance of the Sydney Royal Easter Show.

RAS may in its sole discretion add, withdraw, reschedule or substitute the advertised program for the Sydney Royal Easter Show, including but not limited to performances, artists, attractions and/or exhibitions.

By purchasing tickets through this website and/or attending the Sydney Royal Easter Show, you agree to RAS contacting you in the future with information on special offers or provide you with marketing or promotional materials via any medium including mail, telephone and commercial electronic messages (SMS (Short Message Service), MMS (Multimedia Message Service), IM (Instant Messaging) and email) or any other form of electronic, emerging, digital or conventional communications channel whether existing now or in the future. RAS may share information with its related companies and promotional partners who may also contact you with special offers in this way.

TERMS OF ADMISSION AND ATTENDANCE

Entry into the Sydney Royal Easter Show is at your own risk. Your right of admission into the Sydney Royal Easter Show is not guaranteed by simply purchasing a ticket for admission. RAS reserves its right to refuse your admission and/or eject you from the Sydney Royal Easter Show in accordance with these Terms.

RAS reserves the right to refuse you admission or to eject you from the Sydney Royal Easter Show in its sole discretion, including but not limited to any of the following circumstances:

- a) if you fail to produce appropriate identification as proof of age;
- b) if you have obtained your ticket through illegal means and/or in breach of these Terms;
- d) if you refuse to make your clothes, bags, containers or other possessions available for search by RAS;
- e) if you are found to be in possession of any prohibited items (as set out below);
- f) if RAS suspects that you are affected by the consumption of alcohol and/or drugs;
- g) if you participate in dangerous activities whilst attending the Sydney Royal Easter Show; or
- h) if your tickets are damaged or defaced in any way.

RAS reserves the right to search you and/or your possessions at any time during your attendance to the Sydney Royal Easter Show (including but not limited to at the point of entry).

If RAS discovers that you are in possession of prohibited items, RAS may confiscate such items from you and, where such prohibited items are illegal items, shall contact the relevant authorities. Prohibited items include but are not limited to glass or breakable containers, cans or metal containers, weapons, lasers/laser pointers, flares, fireworks, illicit drugs, alcohol, weapons, knives, skateboards, scooters, rollerblades, bicycles, oversized items (including eskies or bags), animals that are not approved by the RAS and any other item that is determined by the RAS as posing a risk or may cause injury or public nuisance.

Any person gaining unauthorised access to the Sydney Royal Easter Show or any area within the Sydney Royal Easter Show may be prosecuted.

Smoking is not permitted within seated areas or enclosed spaces of the Sydney Royal Easter Show. You must pay attention to and abide by all signs and directions regarding the regulation of smoking at the Sydney Royal Easter Show.

By attending the Sydney Royal Easter Show, you will be entering a licensed area. RAS reminds you that it is an offence for minors to purchase alcohol. Purchasing and/or supplying alcohol to minors is also an offence. Persons supplying alcohol to minors will be reported to police.

The Sydney Royal Easter Show operates rain or shine.

You must abide by all requests and/or commands from security or crowd control staff when attending the Sydney Royal Easter Show. You are also required to follow any instructions and directions from emergency services, police, fire brigade at all times.

There will be lost property and first aid stations at the Sydney Royal Easter Show. The location of these stations is marked out on the Sydney Royal Easter Show location maps located throughout the Sydney Royal Easter Show. Any accidents or emergencies are to be immediately reported to security (24hr) on 9704 1020.

Attendees are responsible for all items brought with them to the Sydney Royal Easter Show. RAS is not responsible for any item that may be lost or damaged at or during your attendance at the Sydney Royal Easter Show.

RAS conducts surveillance on the Sydney Royal Easter Show showground and has access to Sydney Olympic Park security footage and vice versa. A person entering the Sydney Royal Easter Show Showground may be photographed, filmed, taped and/or subjected to monitoring by close circuit television. By entering the Sydney Royal Easter Show showground, you consent to RAS (or third parties appointed by RAS) photographing, filming or taping you. You also agree that RAS may broadcast, publish, licence and use any photographs, film, recordings or images of you in any manner (commercial or otherwise) for an indefinite period without compensation or liability to you.

Entry to and attendance at the Sydney Royal Easter Show is also subject to the **Conditions of Entry to Sydney Showground** and conditions imposed by Sydney Olympic Park Authority from time to time. These conditions may be located at www.eastershow.com.au.
